2. We understand that the charges for annual tuition may be paid in full or in ten equal installments directly to Truth Academy. Should the child(ren) be withdrawn prior to August 31, any prepaid tuition will be refunded, excluding the application fee. We accept responsibility for the full annual tuition except as noted in #3 below. The monthly payment is due regardless of the number of days attended or the number of school days in a month as monthly installments are for payment of annual tuition.

3. We understand that the school reserves the right to dismiss any student who does not cooperate with the educational process. If the student is transferred or withdrawn from school by the parent or guardian for any reason, the account will be reconciled and a final billing or refund (as appropriate) will be forwarded to the financially responsible party. The application fee is non-refundable. A two-week notice in writing is required before financial withdrawal of a child from Truth Academy.

4. We understand that continued enrollment of our student(s) at Truth Academy requires acceptable academic performance and proper conduct as determined by the school staff and administration. Re-enrollment is conditional on acceptable citizenship and academic progress.
